Heard Mr. Ravi Babulkar, Advocate, learned counsel for
the petitioner as well as Mr. J.P. Joshi, Advocate, learned counsel for
the respondent no.1- University and perused the record.

By means of this writ petition, the petitioner has sought a
writ in the nature of mandamus commanding the respondent no. 1 to
issue the admit card to the petitioner of the final examination of B.Ed.
2008-09 session.

By means of Correction Application No. 5033 of 2010,
the petitioner has sought correction in the particulars of the petitioner
in the interim order dated 25-6-2010, as the complete name of the
petitioner has not been typed in the order. By modification application
no.5071 of 2010, the petitioner prays for mentioning the Roll Number
of the petitioner as 162656501 in place of 162656432, as has been
shown in the writ petition. According to the petitioner she has been
allotted new Roll Number by the University later-on when the Admit
Card was issued to her.

The mistake in the complete name of the petitioner has
occurred due to bona fide clerical mistake.

Accordingly, both the applications moved by the petitioner are liable to be allowed.

The correction application No. 5033 of 2010 and modification application no. 5071 of 2010 are allowed. The name of the petitioner Lata Joshi shall be read as “Lata Joshi, at present Lata Kandpal, W/O Himanshu Kandpal, R/O 117 Shashtradhara Road, Rajeshwar Nagar, Phase-I, Dehradun” in the memo of parties in the order dated 25-6-2010. The Roll Number occurring in paragraph 4 of the order dated 25-6-2010 shall be read as 162656501 in place of 162656432. Accordingly, the roll number mentioned in paragraph no.4 as well as in prayer I of the writ petition be read as 162656501 as per the admit card issued by the respondent no.1-University.

The order dated 25-6-2010 be corrected accordingly. To the above extent, this order shall form part of earlier order dated 25-6-2010.

After the petitioner appears in the examination of B. Ed. Session 2008-2009, the respondent no. 1 University shall declare the result of the petitioner also as per its schedule.

With the above observation and direction, the writ petition is disposed of finally.
