BY THE COURT:

I have gone through the FIR and the case diary. Prima facie, I find that offence under sections 3(1)(V)(X) of SC/ST (Prevention of Atrocities) Act, is not made out, however, aforesaid may not be taken as conclusive as it may affect outcome of the trial, but, looking to the facts and circumstances of the case, I am inclined to grant anticipatory bail to the petitioner.

Therefore, the SHO/IO of the Police Station – Govindgarh, Jaipur is directed that in the event of arrest of the petitioner Bhairu Ram in FIR No.9/2010 registered for offence under Section/s 420, 467, 468, 471 and 120-B IPC and section 3(1)(V) (X) of the SC/ST (Prevention of Atrocities) Act, he shall enlarge him on bail provided petitioner furnishes a personal bond in the sum of Rs.40,000/- with one surety in the like amount to his satisfaction on the following conditions:-

- (i)He shall make himself available for interrogation by Investigating Officer as and when required;
- (ii)He shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any Police Officer;
- (iii)He shall not leave India without previous permission of the Court.
- (iv)He shall not commit same and similar offence during the period of bail.
