The illegality in the appointment of the petitioner is writ large from the findings recorded by the District Teachers Appointment Appellate Authority.

The so called degree obtained is highly questionable. Whether it is recognized by the State of Bihar is yet another issue. The tribunal has recorded that the petitioner seems to have been accommodated by the Panchayat Secretary on the ground that she happened to be daughter of the Mukhiya of the Panchyat. Obviously the selection

has been made for extraneous reasons and not entirely on merit as persons having much higher marks and merits have been ignored on the spacious ground that they did not turn up even though information was given Under Certificate of posting.

In large number of cases position has emerged before this Court that even though there is rampant unemployment in the State a stand is taken that information was given under certificate of posting but candidates did not turn up so persons with lesser marks were appointed. It is too much a set pattern to accept such a stand of the respondents. It is a ploy to accommodate the chosen ones.

If it is so, the findings reached by the tribunal does not require interference.

This writ has no merit it is dismissed.
