### ORDER (ORAL) (Passed on this 29<sup>th</sup> day of April, 2011)

- The batch of petitions viz. W.P.(S) Nos. 1442, 1453, 1457, 1461, 1462, 1463, 1472, 1474, 1475, 1476, 1477, 1478, 1511, 1512, 1513, 1514, 1515, 1518, 1519, 1520, 1540, 1541, 1542, 1543, 1574, 1575, 1576, 1577, 1650, 1813, 1814, 1827, 1828, 1829, 1830, 1841, 1867, 1868, 1871, 1872, 1873, 1936, 2029, 2074, 2075, 2117 & 2120 of 2011 involves common facts and common question of law, therefore, the same are being considered and decided by this common order. For the purpose of disposal, facts in W.P.(S) 1520/2011 are set out herein.
- Challenge in these petitions is to the order dated 22/02/2011 (Annexure P/1) whereby the Collector, Korba, exercising his jurisdiction under the provisions of Section 85(1) of the Chhattisgarh Panchayat Raj Adhiniyam, 1993 (for short "the Adhiniyam, 1993") has cancelled the counseling and selection process for appointment of Shiksha Karmi. Grade-III in Janpad Panchayat, Pali, District-Korba.
- 3. The indisputable facts, in brief, are that the petitioners participated in the selection process and in the counseling held on 05/02/2011 & 07/02/2011. Thereafter, the petitioners were appointed. The Collector, Korba, thereafter, passed the impugned order dated 22/02/2011 canceling the selection process and the counseling as aforestated. On the basis of the impugned order dated 22/02/2011, the services of the petitioners, who were duly appointed after selection and counseling, were terminated. Then, the impugned order dated 22/02/2011 was

subsequently modified by order dated 06/04/2011 to the effect of suspending the selection process and the counseling held on 05/02/2011 & 07/02/2011 in lieu of cancellation of the selection and counseling as aforestated in exercise of the power conferred under Section 85 (1) of the Adhiniyam, 1993.

- 4. Learned counsel appearing for the State submits that the order dated 22/02/2011 has been recalled and the order dated 06/04/2011 has been passed where instead of cancellation of the appointment order, the counseling & selection process has been suspended by the Collector.
- 5. In view of the fact that since the order dated 22/02/2011 has been modified to the extent of recalling cancellation of the selection process & counseling, by suspending the same by order dated 06/04/2011, no order passed on the basis of order dated 22/02/2011 can sustain in the eyes of law. As a sequel, the order of termination passed against the petitioners stand cancelled.
- Accordingly, it is not necessary to go into the nature and validity of the order dated 06/04/2011, as the same is not under challenge in the petition.
- Resultantly, the writ petitions are allowed to the extent indicated above.
   No order asto costs.
