The petitioner has filed this petition on the ground that he is a ward of Assistant Teacher who died while in service. He moved an application for compassionate appointment and he has been given appointment on the post of Shiksha Karmi Grade- III. The petitioner submitted that he is entitled to be according to the policy.

Learned State counsel submitted that for the present, the petitioner may be given an opportunity of filling the detailed representation before the competent respondent authority, which may be considered on its own merits, in accordance with law.

Having considered and without expressing any opinion on the merits of the case, in the opinion of this Court, ends of justice will be served, if a direction is given to the petitioner to make a detailed representation raising his grievance before the competent respondent authority along with a copy of the petition and this order, within six weeks from today, and on such representation being filed, the competent respondent authority shall decide the same on its own merits in accordance with law as early as possible preferably within a period of four months from the date of receipt of the representation. If any grievance still remains, the petitioner may avail the remedy available under the law.
