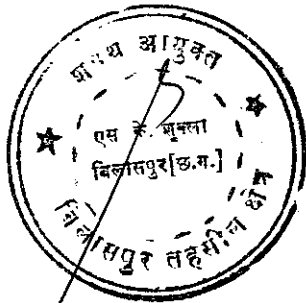

Heard.</p> <p>The petitioner has approached this Court by filing this petition under Article 226 of the Constitution of India aggrieved by inaction on the part of the respondent No.2 in not considering the petitioner's application for transfer of Kerosene Hawker Card after death of her husband-Late Guzoor Sao.</p> <p>Learned counsel for the petitioner submitted that the husband of the petitioner-Late Guzoor Sao was issued Kerosene Hawker Card No.361, who was the only earning member of the family. On 06-12-2009, Guzoor Sao expired. Death certificate of Guzoor Sao has been placed on record as Annexure P-1. It is submitted that after death of Guzoor Sao, the petitioner, who is the widow, applied for transfer of Kerosene Hawker Card in her favour, expressing that the entire family is dependant upon her and she has no other source of income. It is further submitted that the petitioner's family consisting of several members. It is also submitted that though on 26-12- 2009, an application has been moved by the petitioner for transfer of Kerosene Hawker Card, the same has remained undecided.</p> <p>Taking into consideration the submission made by learned counsel for the petitioner and the circumstances of the case, it would be proper to issue necessary directions.</p>
