The petitioners submitted that they are entitled to be appointed as Assistant Teachers according to the policy.</p> <p>Learned State counsel submitted that for the present, the petitioners may be given an opportunity of filling the detailed representation before the competent respondent authority, which may be considered on its own merits, in accordance with law.</p> <p>Having considered and without expressing any opinion on the merits of the case, in the opinion of this Court, ends of justice will be served, if a direction is given to the petitioners to make a detailed representation raising their grievances before the competent respondent authority along with a copy of the petition and this order, within six weeks from today, and on such representation being filed, the competent respondent authority shall decide the same on its own merits in accordance with law as early as possible preferably within a period of four months from the date of receipt of the representation.
