#### **ORAL ORDER:**

In both these petitions, the petitioners challenge the Judgment and Order dated 29<sup>th</sup> April, 2010, passed by District Judge-4, South Goa, Margao in Misc. Civil Appeal No.62/2009/IV, by which the learned District Judge set aside the order dated 17<sup>th</sup> July, 2009 passed by the learned Civil Judge, Sr. Division, Margao in Inventory

Proceedings No.18910/75/A.

- 2. By the impugned Judgment and Order, the learned District Judge has ordered auction to be held of item No.2 and  $2/10^{th}$  of item No.3.
- 3. The learned Counsel appearing for all the parties submitted that the parties would have no objection if a fresh auction is held of item No.2 and item No.3, instead of auction of 2/10<sup>th</sup> of item No.3.
- In view of the consent given by all the parties, the impugned order dated 29<sup>th</sup> April, 2010 is set aside and the Inventory Court is directed to hold a fresh auction in respect of item No.2 and item No.3. Needless to mention that the auction already held in respect of item No.3 pursuant to the order passed by the Inventory Court is set aside.
- 5. Both the petitions stand disposed of accordingly, with no order as to costs.
