THIS M.F.A. COMING ON FOR CONCILIATION BEFORE THE LOK ADALAT THIS DAY, THE FOLLOWING ORDER IS PASSED:

CONCILATION ORDER

This M.F.A. is filed u/s. 173 (1) of M. V. ACT against the judgment and award dated:03-09-2009 passed in MVC NO:15/2003 on the file of the Prl. Civil Judge(Sr.Dn.) and Member, Motor Accidents Claims Tribunal, Hubli.

The learned Counsel for the Appellant and the representative of the Respondent and the learned Counsel for the Respondent are present.

After negotiations, the matter is settled. The 2nd respondent has agreed to pay and Appellant has agreed to receive a global compensation of Rs.95,000/- (Rs. ninety five thousand only) inclusive of interest, in addition to what has been awarded by the Tribunal, in full and final settlement of the claim.

The 2nd respondent shall deposit of Rs.47,500/in any nationalized bank for a period of 909 days from
the date of preparation of Award, failing which the
said amount shall carry interest @ 9% p.a. from the
date of default, till the date of deposit.

We are satisfied that the settlement arrived between the parties is just and proper.

The out of enhanced compensation of Rs.47,500/- shall be released in favour of the Appellant.

This Misc. First Appeal stands disposed of in terms of Joint Memo Award of the Tribunal is modified. Draw the award accordingly.
