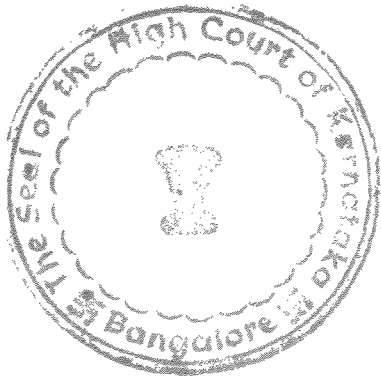
This Writ Petition coming on for orders on this day the court made the following order.
