ORDER

Petitioner, who is the 20th accused in Crime No.792 of 2010 of Kalpetta Police Station for offences punishable under Sections 419, 420, 465, 468 and 471 I.P.C., seeks his enlargement on bail. The petitioner was arrested on 18.01.2011.

2. The learned Public Prosecutor opposed the application contending inter alia that the petitioner was hand in glove with the other accused in dishonestly securing public employment to his daughter Shamseera (A8) by producing forged documents including fake advice memo of the P.S.C and by himself and his son-in-law together paying ₹. 8 lakhs to the racket.

3. Having regard to the gravity of the offences, nature of the allegations levelled against the petitioner, the relative conduct of the parties, the extent of the injury sustained, the propensities of the petitioner, the sentiments of the near relatives of the victim and the other facts and circumstances of the case, I am of the view that if the petitioner is released on bail, he will definitely influence and intimidate the prosecution

witnesses. There is also the likelihood of the petitioner making himself scarce and fleeing from justice. I am, therefore, not inclined to grant bail to the petitioner at this stage.

This petition is accordingly dismissed.
