Assailing the conviction and sentence for offence under Section 138 of the Negotiable Instruments Act in S.T.No.225/2008 as confirmed in Crl.A.No.233/2010 on the file of the Additional Sessions Judge, Mavelikkara, this Revision Petition is filed. Along with the Revision Petition, a petition under Section 147 of the Negotiable Instruments Act is filed.

2. Having heard either side, I find no reason to dismiss the petition. Therefore, the petition is recorded. The revision petitioner would stand acquitted under Section 320(6) of the Code of Criminal Procedure read with Section 147 of the Negotiable Instruments Act. The petitioner shall deposit Rs.3000/- (Rupees three thousand only) before the Kerala State Legal Services Authority within one month and produce the receipt before this Court. In default, the petitioner shall undergo simple imprisonment for two months.
