**J U D G M E N T**

The petitioner herein is working as Lower Primary School Assistant in the school managed by the 4<sup>th</sup> respondent. The main prayer in the writ petition is for a direction to the respondents 1 to 3 to retain the petitioner under the service of the 4<sup>th</sup> respondent as LPSA from the academic year 2010-2011 and grant her all consequential benefits including deprived salary from 15.07.2010.

2. Along with the counter affidavit filed by the Manager, Ext.R4(a) has been produced which is stated to be a revision petition filed before the Government by the Manager. The same is against the non approval of the appointment of respondents 5 and 6.

3. To give a quietus to the entire dispute between the parties, it is only proper that the revision petition is disposed of within a time frame.

Therefore, there will be a direction to the Government to take a decision on Ext.R4(a) revision petition which is filed by the Manager within a period of four months from the date of receipt of a copy of this judgment, after hearing the petitioner and the respondents 4 to 6.

This writ petition is disposed of as above.
