PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners/Accused Nos.3,7 and 8 apprehend arrest at the hands of the respondent police for the alleged offences punishable under Sections 406,420 r/w Section 5 of TANPID Act, in C.C.No.10 of 2010 on the file of the TANPID Court, Madurai and hence, seek anticipatory bail.

2. Heard both sides.


3. The learned Counsel appearing for the petitioners would submit that the petitioners are arrayed as A3,A7 and A8 in C.C.No.10 of 2010 and because of their non appearance due to non receipt of summons from TANPID Court, Madurai, a Non Bailable Warrant has been issued on 14.12.2010 and they apprehends for arrest and hence, they come forward with this application for anticipatory bail.

4. Considering the fact that because of non appearance of the petitioners the Non Bailable Warrant has been issued and it was pending for the past one year, I am not inclined to grant anticipatory bail to the petitioners. However, at the request of the learned Counsel for the petitioners, the petitioners are directed to surrender themselves before the TANPID Court, Madurai and to file an application for re-call warrant and in the event of filing such an application, the TANPID Court, Madurai, is directed to consider the application on the same day and pass orders in accordance with law.

5. With the aforesaid direction, this Criminal Original Petition is disposed of.
