<u>ORDER</u>

The petitioner seeks for a direction to the lower Court to accept the surrender of the petitioner and may consider his bail application on the same day in Crime No.265 of 2011, pending on the file of the respondent police.

- 2. The petitioner is alleged to have committed an offence under Sections 294(b), 323 and 307 I.P.C and Section 3 (2)(V) of the S.C. & S.T(POA) Act. It is stated by the petitioner that he is innocent.
- 3. The learned counsel for the petitioner would submit that the petitioner is prepared to surrender before the lower Court to co-operate with the prosecution and his petition for bail may be ordered to be considered on the same day.

 - ${f 5.}$ Considering the submission of the petitioner that he is innocent and considering the fact that by simply issuing a

direction to the lower Court to dispose of the petition for bail as expeditiously as possible, no prejudice would be caused to the prosecution, the following direction is issued to the lower Court:-

"In the event of the petitioner surrendering before the lower Court and his filing of petition seeking bail, the lower Court shall dispose of the said petition for bail as expeditiously as possible, strictly on merits and in accordance with law. Accordingly, the Criminal Original Petition stands disposed of."
