PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER: The Court Made the following order:-

The petitioners, in both the petitions, apprehend arrest at the hands of the respondent police for the alleged offence punishable under Sections 294(b), 467, 420 and 506(ii) of IPC and under Section 4 of Women Harassment Act, in Crime No.552 of 2011, on the file of the respondent police, seek anticipatory bail under Section 438 of the Code of Criminal Procedure.

3. The case of the petitioners is that they are brothers and they are co-accused in Crime No.552 of 2011. The petitioners/A2 to A3 have sold the common undivided property to the de-facto complainant and it was objected to by A-1, the other brother, the petitioner in Crl.MP(MD)No.17386 of 2011.

- 4.Further, the Accused No.1 has also filed a suit in O.S.No.71 of 2008 before the District Munsif Court, Pattukottai and obtained an order of injunction in I.A.No.122 of 2008 against his brothers and Sub-Registrar not to register the sale deed executed by A2 and A3.
- $5. \, \mathrm{As}$ a counter blast, the de-facto complainant has given a complaint against all the brothers. It is also reported that A-4 has alredy got bail from the trial Court and the A-5 has also obtained anticipatory bail from this Court.
- 6. The learned Additional Public Prosecutor would submit that due to civil dispute, the petitioners have been implicated. He would further submit that investigation is pending and if for any reason, this Court is inclined to grant anticipatory bail to the petitioners, suitable conditions may be passed for the secured presence of the petitioners.
- 7.In the light of the above, I am inclined to grant anticipatory bail to the petitioners, of course, subject to certain stringent conditions.
- 8.Accordingly, the petitioners are directed to be released on anticipatory bail, in the event of their arrest or on their appearanace before the Judicial Magistrate concerned, on executing separate bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Pattukottai, and on further condition that the petitioners shall appear before the respondent police daily at 10.30 a.m. for a period of three weeks.
- 9. The petitioners shall appear before the Magistrate concerned within a period of 15 days, failing which, the anticipatory bail granted shall stand automatically cancelled.
