PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER: The Court Made the following order:-

The petitioner is arrayed as A-1 in Crime No.380 of 2011 on the file of the respondent police, for offences under Sections 147, 148, 341, 294(b) and 302 I.P.C. The petitioner was arrested and remanded to judicial custody on 10.10.2011. He has come forward with this petition seeking bail.

- 2. Heard Mr.V.Kathirvelu, learned senior counsel appearing for the petitioner and Mr.C.Ramesh, learned Additional Public Prosecutor appearing for the State.
- 3. It is reported by the learned Additional Public Prosecutor that the allegation as against the petitioner is that the petitioner being A-1, instigated the other accused to commit murder.
- 4. Considering the above said facts and also considering the fact that there is no specific overt act attributed to the petitioner and the petitioner has been languishing in prison from 10.10.2011 and the other cohttps://hcservices.eccurisgovin/htservices/ released on bail, I am inclined to grant bail to the petitioner, but with stringent conditions.

5. In the result, this petition is ordered and bail is granted to the petitioner on the following conditions: -

(i) The Petitioner shall be enlarged on bail on his executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only) with two sureties each for a likesum to the satisfaction of the learned Judicial Magistrate No.V, Tirunelveli; and

(ii) the Petitioner shall stay stay at Madurai and appear before the K.Puthur Police Station, everyday at 10.30 a.m., until further orders.
