ORDER: The Court Made the following order:-

The petitioners apprehend arrest at the hands of the respondent police for the alleged offence punishable under Sections 465, 467, 468 and 471 I.P.C. in Crime No.33 of 2010, on the file of the respondent Police and hence, seek anticipatory bail.

- 2. Heard Mr.A.Thiruvadikumar, learned counsel appearing for the petitioners and Mr.P.Rajendran, learned Government Advocate (Criminal side) appearing for the respondent State.
- 3. The learned counsel for the petitioner would submit that the petitioners are innocent persons and they have not committed any offence and he prays for anticipatory bail.
- 4. The learned Government Advocate (Crl.side) would submit that there is a civil dispute between the petitioners and the de-facto complainant.
- 5. Considering the rival submissions and also the documents filed by the petitioner, this Court is of the view that the matter is related to civil dispute and hence, this Court is inclined to grant anticipatory bail to the petitioners. Accordingly, the petitioners are ordered to be https://hoseviceaesads.gov/m/hosevices/ in the event of their arrest or on their appearance before the learned Judicial Magistrate concerned and on each of them

executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Alangudi and on further condition that the petitioners shall appear before the respondent police daily at 10.30a.m. for a period of two weeks.
