ORDER

This Criminal Revision is preferred to call for the records relating to the order dated 20.07.2011 passed by the Principal Sessions Judge, Madurai, in Cr.M.P.No.2394 of 2011 in Cr.M.P.No.2260 of 2011, dated 11.07.2011 and set aside the same.

- 2. The petitioner has been charged under Sections 341, 294(b), 535, 379, 420 and 506(i) of IPC. He moved the Principal Sessions Court for bail in Cr.M.P.No.2260 of 2011 on 11.07.2011. The Court had granted him bail with a condition to report before the respondent police daily at 10.00 a.m. for fifteen days.
- 3. It is stated in the present petition and the learned counsel for the petitioner would submit that when the petitioner had gone to appear before the respondent police, he was not allowed to sign and that he was threatened that a false case would be foisted against him. He would further submit that the condition may be modified to the effect that the petitioner may be directed to report before the concerned Judicial Magistrate Court.
- 4. Heard the learned Additional Public Prosecutor appearing for the respondent.
- 5. In view of the circumstances stated above, the condition imposed by the learned Principal Sessions Judge, Madurai, is modified to the effect that the petitioner shall report before the learned Judicial Magistrate No.II, Madurai, every day at 05.00 p.m. for a period of fifteen days.



In the result, the criminal revision case is allowed.
