## ORDER

(Order of the Court was made by S.RAJESWARAN, J.)

WLB COP This petition has been filed by the petitioner to release the crew members, who are said to be under the illegal custody of the respondents. In the last hearing, Mr.K.K.Senthilvelan, the learned Additional Solicitor General, took time to verify and report. The learned Additional Public Prosecutor also took notice.

- 2.Today it is represented by the learned counsel appearing for the petitioner that on the efforts put in by both the District Officials and the Central Government Officials, namely, the Ministry of Shipping, represented by its Secretary and others, all the detenus have been released and they are repatriated to their own country. He also submits that nothing further survives on account of this and the petition may be closed.
- 3.We also place on record our appreciation and the best efforts taken by the petitioner in bringing this detention to the notice of this Court. On account of that, best efforts were taken by the authorities together by the learned Additional Solicitor General and the learned Additional Public Prosecutor to set at liberty the detenus and also for taking steps to repatriate them.
  - 4.Accordingly, this petition is closed.
