Prayer: Writ Petition is filed under Article 226 of the Constitution of India praying for the issue of a Writ of Certiorarified Mandamus, to call for the records in pursuant to the impugned suspension order issued by the second respondent in proceedings R.C.No.0678/B2/2010, dated 24.11.2010 and quash the same and consequently, direct the respondents to reinstate the petitioner with all attendant and monetary and other benefits.

Even though the petitioner has approached this Court by filing the present Writ Petition challenging the impugned order of suspension of the second respondent dated 24.11.2010, the learned counsel appearing for the petitioner states that the petitioner has given a representation dated 18.04.2011 to the second respondent, to revoke the order of suspension and the same could be directed to be considered by the second respondent.

Considering the above said submission made by the learned counsel appearing for the petitioner, I direct the petitioner to send a copy of the representation dated 18.04.2011, which has been sent for revoking the order of suspension, to the second respondent, within a period of one week from the date of receipt of a copy of this order and on receipt of the same, the second respondent is directed to consider the same on merits and in accordance with law, within a period of four weeks thereafter.

5. The Writ Petition stands disposed of in the above terms. Consequently, the connected miscellaneous petition is closed. No costs.
