ORDER

Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondents.

- 2. By consent, the writ petition is taken up for final hearing.
- 3. The petitioner has come up with the present writ petition for a mandamus directing the first respondent to consider the petitioner's representation dated 30.01.2011.
- 4. The case of the petitioner is that he belongs to S.C. Community and obtained degree in Bachelor of Law in Government Law https://hcservices.ecourts.gov.in/hcservices/ hadurai, during the year 2003-2006. He has also enrolled himself as an Advocate in the Bar council of Tamil Nadu on 01.11.2006. After that he had completed Master Degree in law during

the year 2007-2009 at Dr. Ambedkar Law University, Chennai. Now, he is working as a Guest Lecturer in Government Law College, Trichy. While so, the first respondent has called for direct recruitment of Lecturers in Government Law Colleges. The first respondent had originally called for 29 vacancies, of which, six posts were reserved for SC community. The petitioner has submitted an application for the said post. He possesses all required qualification for appointment to the said post. However, he has not been considered for the said post, even though he has sent a representation. Hence, he has come up with the present writ petition for the relief stated earlier.

5. Considering the limited scope of the matter, without expressing any opinion on the claim made by the petitioner, I direct the respondents to consider the representation of the petitioner, dated 30.01.2011, on merits and in accordance with law within a period of six weeks from the date of receipt of a copy of this order.

The Writ Petition is ordered accordingly. No costs.
