Heard Sri V. Nageswara Rao, learned counsel for the petitioners and Sri Dasari S.V.V.S.V. Prasad, learned counsel representing the second respondent and Sri Rudresh Deshpande, learned counsel representing the learned Public Prosecutor/the first respondent.

2. Both the learned counsel placed before the Court for perusal the Memorandum of Understanding, dated 01.11.2010, entered into between the second respondent and

Sri G. Satyanarayana on the one hand and the petitioners 1 and 2 on the other settling all the matters between them as per the terms and conditions mentioned therein. Condition No.8 recorded both the parties agreeing to get the proceedings in D.V.C.No.1 of 2010 quashed in this criminal petition.

- 3. The Memorandum of Understanding is returned on perusal.
- 4. The affidavit of the second respondent has also been filed in which she stated that she filed D.V.C.No.1 of 2010 before the Additional Judicial Magistrate of First Class, Narasapuram, and due to intervention of elders and mediators, both the entered of parties into the Memorandum Understanding, dated 01.11.2010. She further stated that she agreed to withdraw the allegations in D.V.C.No.1 of 2010 and also the domestic violence case and, therefore, she has no intention to continue the said proceedings. She further stated that the further proceedings in D.V.C.No.1 of 2010 may, therefore, be quashed.
- 4. In the light of the affidavit on oath from the second respondent in pursuance of Memorandum of Understanding between the parties, dated 01.11.2010, the criminal petition has to be ordered.

5. Therefore, the further proceedings in D.V.C.No.1 of 2010, on the file of the Additional Judicial Magistrate of First Class, Narasapuram, West Godavari District, are quashed and the Criminal Petition is allowed accordingly.
