This is a petition for quashing of FIR No. 466/2009 under Sections 498A/406/506 registered at P.S. Amar Colony, Lajpat Nagar registered on the complaint of Petitioner No.2 Ms. Neeru Chadda.



The Complainant/ Petitioner No.2 Ms. Neeru Chadda is present in person and is identified by her counsel and investigating officer. She states that the Petitioners and Respondent No.2/Complainant have entered into a Compromise before the Mediation Center of Delhi High Court. Parties have complied with the terms of settlement copy of which has been placed on record as Ex. 'C'. In terms of the settlement, marriage between the Petitioner No. 1 and Respondent No. 2/Complainant has been dissolved by a decree of divorce by mutual consent. As part of full and final settlement of all the claims of the Petitioner No. 2, the Petitioner No. 1 has already paid Rs. 3 lakhs to her. She further states that in view of the settlement between the parties, she does not want to pursue the abovementioned FIR and the proceedings pursuant thereto.

In view of the fact that the parties have amicably resolved their differences of their own free will, volition and without any coercion and no useful purpose will be served in continuance of the proceedings, rather the same would create further acrimony between them, it would be in the interest of justice to quash the abovementioned FIR and the proceedings pursuant thereto. There is no legal impediment in quashing the abovementioned FIR

Consequently, FIR No. 466/2009 under Sections 498A/406/506

registered at P.S. Amar Colony, Laipat Nagar and proceedings pursuant thereto are hereby quashed.

Parties have signed this order sheet in acknowledgment of their statements made before this Court.
