parties as well as their counsels and is supported by their respective affidavits. The application is marked as Ex.C-1.

- 3. The compromise between the parties is lawful and is recorded. Both the suits are decreed in terms of the compromise-Ex.C-1. Both the parties shall remain bound by their respective obligations under the said compromise.
- 4. In terms of the compromise-Ex.C-1, learned counsel for M/s Hydrobaths Ramco Marketing Pvt. Ltd. has handed over the keys of the basement to one of the landlords, Satnam Singh Bola in court. M/s Hydrobaths Ramco Marketing Pvt. Ltd. has undertaken to vacate the first floor of the suit property on or before 28th February, 2013 and has further undertaken to pay ₹1,30,000/- per month as use and occupation charges till then. The undertaking of M/s Hydrobaths Ramco Marketing Pvt. Ltd. is accepted and the decree for possession of the first floor of property bearing No.M-31, Greater Kailash-II Market, New Delhi is passed in favour of Satnam Singh Bola and Sukhdev Singh Bola and against M/s Hydrobaths Ramco Marketing Pvt. Ltd. However, the decree shall not be executable till 28th February, 2013 unless there is two execution defaults in payment of the use and occupation charges @₹1,30,000/- per month. page 2 of 3 CS(OS) 2588/2010 & CS(OS) 25/2011



outstanding arrears up to February, 2011 shall be paid by M/s Hydrobaths Ramco Marketing Pvt. Ltd. within eight weeks in terms of para 5.4 of Ex.C-1.

- 5. The undertakings of M/s Hydrobaths Ramco Marketing Pvt. Ltd. are accepted and they shall remain bound by the same.
- 6. All the pending applications stand disposed of.
- 7. Copy of this order be given 'Dasti' to learned counsel for the parties under signatures of Court Master.
