Petitioner has preferred this writ petition alleging that he filed an application for re-evaluation of his result of Management Accounting-I bearing subject code No. 105 of 1st Semester Examination, 2009, but his result of re-evaluation has not been declared so far, whereas petitioner has already cleared his all semesters, therefore, respondents be directed to declare the result of petitioner for his re-evaluation.

3. Learned counsel for respondents submitted that during pendency of this writ petition, the respondents have already declared the result of petitioner for his re-

evaluation of subject M-105, therefore, this writ petition has become infructuous.

4. Learned counsel for petitioner admitted this position and submitted that petitioner has been declared as 'pass' and he has received his marks sheet of this particular subject but his complete marks sheet after inclusion of marks awarded in subject M-105 in re-evaluation, has not been issued despite number of requests made in this behalf, therefore, a limited direction be issued to respondents to issue complete marks sheet to the petitioner.

5. I have considered the submissions of learned counsel for the parties. As admitted by both parties, the writ petition with regard to declaration of result of re-evaluation has become infructuous, therefore, the writ petition is disposed off with a limited observation and direction that in case petitioner files an application for issuing complete marks sheet, then Registrar, Rajasthan Technical University, Kota, will provide the same at the earliest, but not later than a period of ten days from the date of receipt of application.
