ORAL ORDER

3 29-06-2012 Heard the learned counsel for the petitioners, the informant and the State.

This is a petition for grant of regular bail for offence under Section 302 and allied sections of the Penal Code.

The petitioners were last seen along with the deceased and eight persons have been named accused in the first information report with whom the deceased was alleged to have been seen along with the deadly weapon on 29.01.2012. However, the db was recovered on 31.01.2012. From the order of the Session's Judge, it is apparent that only material against the petitioners is that the deceased was last seen with the petitioners on 29.01.2012. There is no eye witness to the occurrence and the case hinges on circumstantial evidence, however, the dead body was recovered from a well.

Hence, having regard to the facts and circumstances of the case, the petitioners, above named, are directed to be released on bail on furnishing bail bonds of Rs.10,000 (rupees ten thousand) each with two sureties of the like amount each in connection with Dhansoi P.S. Case No. 7 of 2012 to the satisfaction of the Chief Judicial Magistrate, Buxar, subject to the condition that the petitioners shall appear in Court on each and



every date, fixed in the case and any absence, on two consecutive dates, without any reasonable ground to the satisfaction of the Court below, shall be a ground of cancellation of bail of the petitioners by the lower Court itself
