Learned counsel for the parties agree that the issue involved herein is identical which was involved in C.W.J.C.No. 5278/2004 and its analogous cases which were disposed of by an order dated 26.2.2007.

Mr. Prabhakar Tekriwal, however, informs that when those 176 cases were examined by the Director, Primary Education and the Committee, it was found that none of them had any merit and their claims were rejected.

Learned counsel for the petitioners submits that the facts of both these cases of the petitioners will be, however, required to be gone into.

This Court without expressing any opinion on the submission made by the learned counsel for the petitioners would direct the Director, Primary Education himself to examine the grievance of the petitioners in both these cases and take a decision in terms of the order passed in C.W.J.C.No. 5278/2004.

In order to expedite this matter both the petitioners are given liberty to file their fresh representation giving details of their claim as also enclosing a copy of this order, whereafter the Director, Primary Education shall do the needful within a period of six months from the date of receipt of the order.

With the aforementioned observation and direction, both the applications are disposed of.
