Learned counsel for the parties however, bring to the notice of this Court, an order dated 21/03/06 passed in writ petition no.325/99 by the Division Bench of this Court by which the Court has set aside the order of the Tribunal on the ground trat Tribunal did not have competence and jurisdiction to decide the matter.
