ORDER

(Passed on this 11th day of May, 2012)

- 1. Learned counsel appearing for the petitioner submits that the issue involved in the case is asto whether, the petitioner is entitled to regular pay scale w.e.f. the date of initial appointment or after completion of probation period.
- 2. The issue involved, herein was considered by the Madhya Pradesh State Administrative Tribunal, Jabalpur in O.A. No.2745/89 (Madhukant Yadu and 56 others Vs. State of M.P. & others), wherein it was held that the similarly situated teachers are entitled to regular pay scale w.e.f. the date of initial appointment. The matter was taken up to Supreme Court in Special Leave Petition (Civil) No.6892/93. The said petition was dismissed by the Supreme Court upholding the decision of the Tribunal to the effect that the Teachers/Assistant Teachers are entitled to regular pay scale from date of initial appointment. The State has also issued a circular to that effect on 05.01.2011.
- 3. Accordingly, the petitioner is granted liberty to make a representation raising all the grievance and in turn, the concerned respondents are directed to decide the representation, if any, in accordance with law, on its own merits, within a period of eight weeks from the date of receipt of the representation.
- 4. In view of the foregoing, this petition is disposed of. No order asto costs.
