ORAL ORDER (29.06.2012)

The following order of the Court was passed by **Abhay Manohar Sapre, J.** 

Heard.

(2) The decision rendered in Writ Appeal No.88/2007, shall also govern the disposal of other connected appeals mentioned above, because, all these appeals firstly arise out of the same



impugned order and secondly, they involve common question of law and fact.

- (3) This is an appeal filed by the writ petitioner of W.P. No. 4108 of 2005 under Section 2 (1) of the Chhattisgarh High Court (Appeal to Division Bench) Act, 2006 against the common order dated 6<sup>th</sup> of February 2007 passed by the learned Single Judge in the aforementioned writ petition and other connected writ petitions.
- (4)The question involved in the writ petition and which came to be decided by the writ Court in the impugned order, out of which, this intra Court appeal arises, was whether the Teachers working in Government aided schools in the State Chhattisgarh entitled claim the benefit of are to recommendations made by the 5th Pay Commission under the provisions of the Madhya Pradesh Ashaskiya Sikshan Sanstha (Adhyapakon Tatha Anya Karamchariyon Ke Vetano Ka Sandaya) Adhiniyam, 1978 read with rules framed\_there under?
- (5) The aforesaid question was debated and eventually decided by the learned Single Judge (writ Court) in affirmative i.e. in favour of the writ petitioners (teachers) and against the State, which resulted in allowing of the writ petitions of the Teachers working in the concerned schools.
- (6) This is what the concluding paragraph of the impugned order of the writ Court reads:

"In view of the submission made by learned counsel appearing for the RESPONDENT(S) that there would be a substantial financial burden on the State Exchequer, it is appropriate to give following directions in regard to payment of arrears:-

(i) The petitioners shall be payable the revised pay-scales immediately with effect from



01.10.2006 in accordance with the Pay Rules, 1998.

- (ii) The difference of amount of payment with effect from 1-1-1996 till September 2006, as a result of the revised pay-scales, shall be payable in ten six-monthly installments.
- (iii) The said amount may be payable to the General Provident Fund of the teacher concerned carrying interest equal to the interest payable to the General Provident Fund of the concerned teacher."
- the State of Chhattisgarh were admitted by a Division Bench of this Court, presided over by Hon'ble Mr. Justice H.L. Duttu, Chief Justice (as his Lordship then was) and Hon'ble Mr. Justice D.R. Deshmukh, on 25.04.2007, and their Lordships while admitting these appeals, only for examining a short question namely whether the direction given by the writ Court to pay the arrears of salary to Teachers in ten six monthly installments is legally and factually sustainable or it needs some modifications. It is apposite to quote the order dated 25.04.2007 in verbatim infra.

"Heard Shri VVS Murthy, Dy. AG for the State/appellant.

Learned Dy. AG confines this writ appeal only to paragraph 7 of the memorandum of appeal. Paragraph reads as under:

"That the Learned Single Judge, considering the total amount involved, ought to have been more liberal in total number fixing the installments and making it annual instead of 6 monthly. Under the circumstances, the judgment/order of the Learned Single Judge is liable to be set aside/reversed, alternately, is liable to be modified, so as to exgenerate the State of Chhattisgarh from the liability of payment of the amount disputed in the appeal or





alternatively to make the installments annual and more liberal."

In the said paragraph and in other paragraphs, the State Government has pleaded its financial difficulties to pay the amounts as directed by the learned Single Judge. The grievance of the appellant in this regard appears to be bonafide, genuine and reasonable. Therefore, notice to the learned counsel who had appeared before the learned Single Judge requires to be issued to decide only paragraph 7 of the memorandum of writ appeal. Accordingly, the following:

#### **ORDER**

- 1) Issue notice Shri Sanjay K. Agrawal, Shri Ashish Shrivastava, Shri Manoj Paranjpe, Mrs. Fouzia Mirza, Shri Arun Kumar Shukla, Shri Sanjay Ram Tamrakar, Shri Shankar Patel, Shri Ramakant Pandey, Shri Ramakant Mishra, Shri Neel Kanth Malviya, Shri Anoop Mazumdar, Shri Anurag Dayal Shrivastava, Shri V.K. Pandey, Shri Y.C. Sharma, Shri Anupam Dubey, Shri Shailendra Shukla, Ms. Sunita Jain, Shri Saurabh Sharma, Shri Saurabh Sahani, Shri Sachin Singh Rajput, Shri A.K.Yadav, Shri Raghvendra Pradhan and Shri S.S. Mishra, Advocates for the petitioners in writ petitions filed before the learned Single Judge.
- 2) Any order that would be passed by us would be subject to the decision of the SLP said to be pending before the Apex Court, filed by the State of Madhya Pradesh in more or less similar matters.
- (8) It is not in dispute that the identical issue, which is the subject matter of this appeal, was also subject matter of another bunch of writ petitions/appeals before the High Court of Madhya Pradesh (prior to 01.11.2000) at principal Bench of High Court of Jabalpur and the High Court of Madhya Pradesh by judgment dated 29.01.2003 passed in L.P.A. No.48/03 has held that the Teachers working in the State of Madhya Pradesh in various Government aided schools are entitled to take benefit of the 5th Pay Commission and accordingly, orders were passed





directing them to give such benefit. It is also not in dispute that the State has felt aggrieved and filed SLP No.639/2004 before the Supreme Court of India. It is pending consideration for its final disposal and the judgment is awaited.

- (9) Having heard the learned counsel for the parties and keeping in view the background narrated above, we notice that this appeal involves only a short point i.e. Whether the learned Single Judge (writ Court) was justified in giving direction to pay the arrears in ten six monthly installments? In other words, the question that really arises for consideration in this appeal at the instance of the State is, Whether the learned Single Judge was justified in directing payment of arrears of salary payable to the Teachers in ten half yearly equal installments? According to the State, the learned Single Judge should have been more liberal in fixing the installments than what have been fixed i.e. it should have been more than 10 installments.
- (10) Mr. V.V. S. Murthy, learned Deputy Advocate General for the State/appellants fairly conceded that after passing of the impugned order, the State has so far paid 50% (5 installments) of the total claim of the teachers as per impugned directions of the learned Single Judge and now only 5 installments remain to be paid to the Teachers.
- (11) In our opinion, taking into account all facts and circumstances of the case and the fact that 50% of the amount towards full arrears have already been paid and further that issue is sub judice in the Supreme Court at the instance of the State of M.P., we consider it just and proper and in the interest of justice to modify the impugned direction in part and direct that the balance 50% of the arrears, which was otherwise payable on or before February 2012 in terms of impugned directives, would now be payable/paid within 2 ½ years i.e. on or before August 2014 in six monthly equal installments by the



State to the Teachers concerned. In other words, the State will now pay remaining 50% of the balance of arrears in terms of the impugned order on or before August 2014 in six monthly (half yearly) equal installments. The installments now be accordingly paid.

- (12) We also consider it apposite to observe, as mentioned in order dated 25.04.2007 supra that this decision shall be subject to the result of eventual order that will be passed by the Supreme Court in Civil Appeal No.6399/2004, which arises out of the order passed by the High Court of Madhya Pradesh in LPA No.48/03, because, issue involved in this case and the one involved in the case pending before the Supreme Court is identical. We also direct that depending upon the directions given by the Supreme Court in the order, the State will always be entitled to pass consequential orders in respect of all institutions and the affected teachers to ensure implementation of the order passed by the Supreme Court, if required. Indeed, on this issue both the learned counsel for the parties fairly agreed.
- (13) Subject to aforesaid modifications in the impugned order, the appeal stands finally disposed of.
- (14) The original order shall be kept in the records of Writ Appeal No.88/2007 and the copies of the same shall be kept in the records of other connected appeals.

(15) No order as to cost(s).
