## **ORAL JUDGMENT** (Per B.P. Dharmadhikari, J.):

1. Heard respective Counsel.

- 2. Rule. Rule made returnable forthwith. Heard by consent.
- 3. It is not in dispute that request made by the petitioner to correct his date of birth in S.S.C. certificate has been turned down by the respondent nos.2 and 3 because it has been made after three years.
- 4. Adv. Mr. Gaware, for the petitioner, has invited attention to Circular dated 2nd March 2012 issued by respondent no.2 which permits such application to be entertained without any time limit but subject to levy of amount of Rs. 100/- per year in slabs as stipulated therein.
- 5. Adv. Mr. Soman, for respondent nos.2 and 3, states that he would like to obtain instructions from his clients about this circular.
- 6. We accept circular produced by Adv. Mr. Gaware, for the petitioner, and same is marked as Exhibit "X" for identification. Statement made by Adv. Mr. Gaware is also accepted.
- 7. In view of the statement and circular, we set aside the impugned communication dated 16th October 2010 (Exhibit "I"), sent by respondent no.4 / School. We direct respondent nos.2 and 3 to entertain the request of the petitioner in terms of Circular dated 2nd March 2012, and take appropriate decision upon it, within a period of six weeks, after the petitioner appears before respondent no.3. Petitioner shall appear before respondent no.3 on 10th September 2012, and abide by his further instructions in the matter.
