2. By the impugned orders, the learned Single Judge has directed the 2<sup>nd</sup> respondent – Deputy Commissioner, Gulbarga to recover money covered under the Recovery Certificate dated 20.3.2003 as expeditiously as possible.

3. Copy of the writ petitions are produced alongwith the writ appeal papers. The prayer of the petitioners in the writ petitions is for a direction to Respondent No.2 to recover certain amount apart from other benefits towards credit of leave with pay from Respondent Nos.4 and 5 alongwith interest thereon. In view of the same, the learned Single Judge ought to have issued notice to Respondent Nos.4 and 5 in the writ petitions i.e., the appellants herein. Since the say of the appellants is necessary, the learned Single Judge ought to have heard

them. In addition to the same, Sri Chidanandayya, learned advocate appearing on behalf of the appellants submits that similar two writ petitions, which were filed by the workmen were dismissed.

Be that as it may, since we find that notice to Respondent Nos.4 and 5 in the writ petitions i.e., appellants herein is necessary, the impugned orders passed by the learned Single Judge in the writ petitions stand set aside. The matters are remitted to the learned Single Judge for fresh disposal in accordance with law. Writ Petitions are restored to the file of the learned Single Judge.

Writ Appeals are **allowed** accordingly.
