This Criminal Petition is filed under Section 482 of Cr.P.C. to quash final report on the file of the XI ACMM Mayo Hall, Bangalore for the offence punishable under Sections 498(A), 506 r/w 34 of IPC and Sections 3 and 4 of D.P.Act in C.C.No.24191/07 against the petitioners as per Ann-L.

This Petition coming on for Hearing this day, the Court made the following:-

ORDER

The petitioners have sought for quashing of the proceedings in C.C.No.24191/2007 on the file of the XI Addl. Chief Metropolitan Magistrate, Mayo Hall unit, Bangalore.

2. During the pendency of the proceedings, the parties have compromised their dispute. Respondent No.2 is the wife of petitioner No.1 and she is the complainant. A

compromise petition signed by both the parties and their counsel has been filed. The dispute is between petitioner No.1 and respondent No.2 who are husband and wife. Now, the matrimonial dispute has been settled amicably. In terms of the settlement, the petitioners are tendering two Demand Drafts for Rs.8,00,000/- and Rs.50,000/- in favour of respondent No.2. Respondent No.2 is also present before the Court and she acknowledges the receipt of Demand Drafts for Rs.8,50,000/- and also submits that the matter is compromised and proceedings may be quashed.

3. Placing the submission on record, petition is allowed. Proceedings in C.C.No.24191/2007 on the file of the XI Addl. Chief Metropolitan Magistrate, Mayo Hall unit, Bangalore stands quashed.
