This MFA is filed u/s 173(1) of MV act against the Judgment and award dated 21.05.2010 passed in MVC No. 713/2009 on the file of the III Additional District Judge, Member, Mact, D.K., Mangalore, Partly Allowing the claim petition for compensation and seeking enhancement of compensation.

This MFA coming on for conciliation before Lok Adalat after being referred vide order dated 18.08.2011. The following order is passed.

CONCILIATION ORDER

The learned counsel for the Appellant -Claimant and the learned counsel for Insurance Company along with its representative are present.

- 2. After prolonged negotiations, the matter is settled. The appellant –claimant has agreed to receive and the Respondent No.2 United India Insurance Company Limited has agreed to pay a lump sum of Rs.30,000/-(Rupees Thirty Thousand only) in addition to what has been awarded by the Tribunal, in full and final settlement of the claim. A Joint Memo is filed today on behalf of the parties to this effect.
- 3. The Respondent No.2 United India Insurance Company Limited has agreed to deposit the said amount before the Tribunal, within six weeks from the date of preparation of Award, failing which the said amount shall carry interest at the rate of 9% per annum from the date of default, till the date of deposit.
