Justice Kurian Joseph, C.J. (oral):

The 2nd respondent has come in appeal aggrieved by the order dated 10.5.2012 passed in CMP No. 4828 of 2012 in CWP No. 1846 of 2011. The issue pertains to the framing of Rules for appointment to the various posts in the Nursing Colleges. The allegation made is that the Rules are not being framed and hence, the unqualified persons are being continued to hold various posts.

2. CWP No.1846 of 2011 was disposed of with the direction to frame the Rules before 31.7.2012. Thereafter, the State moved an application for extension of time and the Court

in CMP No. 4828 of 2012 in CWP No. 1846 of 2011 has passed

the following order on 10.5.2012:-

"The time for framing the Rules is extended upto

31st July, 2012 and the time for filling up the post in

accordance with the Rules so framed is extended upto 31st

October, 2012. It is made clear that no further extension of

time will be granted. In case the Rules are not framed or

appointment is not made then respondent No. 2 shall not be

entitled to continue on the said post."

3. We make it clear that the appellant will continue as

the Principal till the selection and the appointment to the post

of Principal in terms of the new Rules are made. It is further

made clear that the 1st respondent shall not draw salary from

the month of April, 2013 onwards unless the whole process, as

above, is completed before 31.3.2013. The Registry shall

communicate this judgment to the Principal Secretary (Health)

to the Govt. of H.P.

4. With these observations, the present appeal is

disposed of, so also the pending application(s), if any.
