It is seen from the affidavit that the adhoc service rendered by the petitioners, as per record maintained with the respondents, has been counted, as per the judgment, for the purpose of fixation of pension. Learned counsel for the petitioners submits that the adhoc service is actually from June, 1967, whereas the respondents have counted the same only from August, 1967. In case the petitioners have any proof with regard to the period, it will be open to them to point out the same before the Block Elementary Education Officer and in case it is established as per the record that the petitioners have actually worked from June, 1967, the benefits shall be granted from that period. In case any of the petitioners approaches the Block Elementary Education Officer, he shall be permitted to verify the records.

2. Subject to the above, contempt petitions are dismissed. Rule discharged.
