JUDGMENT

Thottathil B.Radhakrishnan, J.

- 1. The appellant, a financier, moved the court below for an interim measure under section 9 of the Arbitration & Conciliation Act, 1996. That was refused. This Court granted an interim order at the stage of admission, whereby, a stage carriage was attached. Since there was none to take it into custody; to prevent its deterioration, it was ultimately sold through the court below, pending this appeal, under order of this Court. Money is lying in deposit with the court below.
- 2. The arbitral proceedings on the basis of the agreement in relation to which the appellant financier went to the court below under section 9 of the A&C Act is not yet over. This means that whatever has been pushed under section 9 has to

be protected pending that arbitral proceeding, to enable the parties to await its result.

- 3. Learned counsel for the contesting third respondent says that his client had purchased the rights over the stage carriage from the person who was in possession of that vehicle. He also says that there is documentary evidence to show that the appellant Kotak Mahindra Bank Ltd. had certified that the entire amount due on account of that stage carriage had been paid.
- 4. In the aforesaid facts and circumstances, this appeal is ordered as follows:
 - (i)The amount lying in deposit being one in satisfaction of orders issued by this Court in appeal and, therefore, relatable to section 9 of the A&C Act, shall be released by the court below to the appellant, pending the arbitral proceedings on the

basis of the agreement in relation to which the parties were before the court below in proceedings under section 9 of the Act, if the appellant furnishes bank guarantee to the satisfaction of the court below, for the amount lying in such deposit before the court below.

- (ii) Having regard to the peculiar contentions of the third respondent, the appellant agrees, and it is therefore directed that the third respondent shall be a party to, and shall be permitted to participate in the arbitration proceedings and shall be permitted to plead, including as to discharge and satisfaction of the claims of the appellant financier as against the stage carriage concerned.
- (iii)Appeal ordered accordingly without expressing anything on merits.

(iv)Re-transmit LCR with copy of the judgment at the earliest.
