ORDER

The petitioner is the accused in Crime No.248/2012 of Contonment Police Station, Thiruvananthapuram for offence punishable under Section 376 IPC. The petitioner was arrested on 17-03-2012. When produced before the Judicial Magistrate of the First Class – III, Thiruvananthapuram, he was remanded to judicial custody. His application for bail was dismissed by the learned Magistrate as well as by the learned Sessions Judge and now this petition seeking an order to release the petitioner on bail.
