ORDER

The petitioners are accused Nos.2, 3 and 4 in Crime No.283 of 2012 of Rajapuram Police Station for having committed offences punishable under Sections 341, 323, 255B and 332 read with Section 34 I.P.C..

2. After having heard learned counsel for the petitioners, learned Public Prosecutor and on perusing the records made available, it is felt that this is a fit case where the extraordinary jurisdiction needs to be exercised in favour of the petitioners.

Therefore, this application is allowed on the following conditions:

- i) Petitioners shall surrender before the Investigating Officer on or before 10.10.2012, who after interrogation shall produce them before the JFCM concerned, which court, on applications

for bail being moved the petitioners shall release them on bail on each of them executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two solvent sureties each for the like sum each to the satisfaction of the JFCM concerned.

ii) The learned Magistrate may ensure the identity of the sureties and the veracity of the tax receipts produced by the sureties for the purpose of executing the bond.

iii) Petitioners shall make themselves available for interrogation as and when required by the Investigating Officer.

iv) Petitioners shall not tamper or attempt to tamper with the evidence or influence or try to influence the witnesses.

v) If any condition is violated, bail granted to the petitioners shall stand cancelled, and the JFCM

concerned, on being satisfied of the said fact, may take such proceedings as are available to him in law.
