JUDGMENT

K.M. Joseph, J.

Petitioners are the appellants. They challenged the levy of building tax from them contending that they are lessees under the first respondent.

- 2. The learned Single Judge did not find merit in their argument, noting that the agreements provide that the lessees shall pay all taxes and, therefore, the appellants have a liability to pay tax under the Building Tax Rules. However, we note that the appellants at this stage sought time for payment. Accepting the request of the appellants, the learned Single Judge granted instalment facility.
- 3. We heard the learned counsel for the appellants. Learned counsel for the appellants seeks to argue the merits of the matter. We feel that the appellants should be relegated to file a Review

Petition, if so advised. Without prejudice to the right of the appellants to seek review before the learned Single Judge, the Writ Appeal is disposed of.
