J U D G M E N T

The petitioner purchased some wheat from the 1st respondent by paying the price fixed for the same. The petitioner has now been directed to pay differential price on the ground that the wheat was under-priced by the respondents. Against the same, the petitioner has filed Ext.P9 representation before the 2nd respondent. The petitioner seeks expeditious disposal of Ext.P9.

Having heard the standing counsel for the respondents , I am of opinion that it is more appropriate that the 1st respondent considers Ext.P9. In the above circumstances, this writ petition is disposed of with a direction to the 1st respondent to consider and pass orders on Ext.P9, as expeditiously as possible, at any rate within one month from the date of receipt of a copy of this judgment. Till then, the recovery shall not be enforced.
