JUDGMENT

All the petitioners are seeking for a direction to the University to complete the revaluation of their answer papers and publish the results within a time frame. It is pointed out in the writ petition that the last date for submitting the application was on 19.3.2012 and they have submitted the applications well in time and that 45 days have expired on 4.5.2012. It is also submitted that in the light of the decision of this Court in **Nithya v. Cochin University of Science and Technology** (2012 (1) KLT 584), the revaluation results will have to be published within a period of 45 days from the last date fixed for applying for revaluation.

2. There will be a direction to the University to complete the process of revaluation and inform the results to the petitioners within a period of thirty days from the date of production of a copy of this judgment.

The writ petition is disposed of as above. No costs.
