JUDGMENT

The petitioner, a permanent driver of the 1st respondent Corporation, met with a motor vehicle accident on 24.05.2010. He sustained serious injuries and his right leg was amputated above the knee. Ext.P1 are his treatment records. According to the petitioner, he is entitled to special disability leave for the period of his treatment. Though he has submitted Ext.P2 application seeking such leave, he complains that no orders have been passed thereon till date.
