## ORDER

- 3. The grievance of the petitioner is that the TASMAC Wine Shop No.6319 is situated in the main bazaar area and very near to the Perambalur Old Bus Stand at Perambalur Town. He requested the authority by way of representation dated 13.10.2012 either to close or shift the same to some other place. Since, the said representation has not been considered so far, the mandamus is filed.
