## JUDGMENT

The Second Appeal has been filed against the Judgment and Decree passed by the Learned Subordinate Judge, Hosur dated 09.12.2002 made in A.S.No.6 of 2000 in reversing the judgment of

decree passed by the Learned District Munsif, Denkanikottai dated 30.11.1999 made in O.S.No.13 of 1993.

- 2.Mr.Sanjai Babu, learned counsel appears for the appellant and Mr.V.Nicholas, learned counsel appears for the first respondent. A memorandum, giving up the claim against the respondents 2 to 8 is filed and recorded.
- 3.A joint memorandum of compromise has also been filed by the second appellant and the first respondent. The second appellant and the first respondent were present in Court and admitted the terms of the joint memorandum of compromise. Hence, the joint memorandum of compromise filed by them is ordered to be recorded.
- 4.In view of the recording of the joint compromise entered inbetween the second appellant and the first respondent, the appeal is allowed to that extent and the first Appellate Court judgment and decree is modified to the effect that a decree is passed in terms of compromise. The joint memorandum of compromise shall form part of the decree. No orders as to costs.
