Writ Petition filed under Article 226 of the Constitution of India praying for a writ of Mandamus directing the respondent and all officers subordinate him to accept tax for seven days or 30 days or the entire quarter as and when voluntarily tendered by the petitioner in advance anywhere in the state of Tamil Nadu in respect of the petitioner's vehicle KA-21-8598 to ply in Tamil Nadu Roads without obstruction.

Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondent.

2. At this stage of the hearing of the writ petition, the learned counsel appearing for the petitioner had submitted that the issues involved in this writ petition are covered by the order of this Court, dated 24.4.2007 made in W.P.Nos.15061 to 15063 of 2007, and the order , dated 27.04.2011, passed in W.P.No.11095 of 2011, wherein, this Court had directed the respondents therein to receive the tax, as and when it is voluntarily tendered, by the petitioners therein, in advance, for 7 days, 30 days or 90 days, without insisting on the payment of 1/10th of the quarterly, tax for every entry into Tamil Nadu, in respect of the petitioner's vehicles concerned.

3. In view of the submissions made by the learned counsels appearing for the parties concerned and in view of the order passed by this Court, on 24.4.2007, in W.P.Nos.15061 to 15063 of 2007, and the order, dated 27.04.2011, made in W.P.No.11095 of 2011, the writ petition is disposed of, directing the respondent to receive the tax, as and when it is voluntarily tendered by the petitioner, in advance, for 7 days, 30 days or 90 days, without insisting on the payment of 1/10th of the quarterly tax, for every entry into Tamil Nadu, in respect of the petitioner's vehicle, bearing registration No. KA-21-8598. No costs.
