3.The learned Additional Public Prosecutor submits that no one sustained injury in the alleged occurrence and the investigation is almost over.

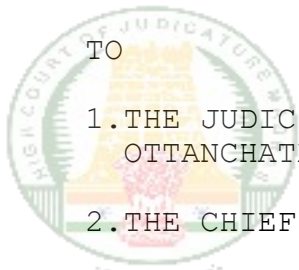
