PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

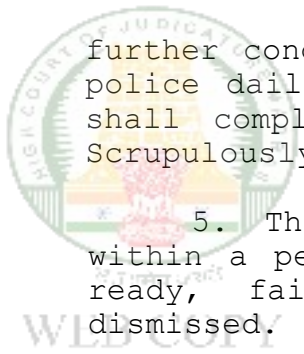
ORDER : The Court Made the following order :-

The petitioner in all these Criminal Original Petitions apprehends arrest at the hands of the respondent police for the alleged offences punishable under Sections 406 & 420 I.P.C., in Crime No.107 of 2011, Crime No.106 of 2011 and Crime No.128 of 2011 and hence, seeks anticipatory bail.

2. It is submitted by the learned counsel for the petitioner that the petitioner is an innocent person and he has not committed any offence and prays for anticipatory bail in favour of the petitioner.

3. The learned Additional Public Prosecutor submitted that the petitioner is arrayed as A-4 in Crime Nos.106 and 107 of 2011 and A-6 in Crime No.128 of 2011. He further submitted that the petitioner undertakes to compromise the matter and therefore, he was arrayed as accused for the offences stated above. He further submitted that A-1 to A-3 were granted bail by the Sessions Court.

4. Considering the fact that A-1 to A-3 were granted bail by the Sessions Court and the petitioner only acted as Mediator, I am inclined to grant anticipatory bail, but with certain conditions. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance before the learned Judicial Magistrate, on executing a bond (in each of the cases) for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and on



further condition that the petitioner shall appear before the respondent police daily at 10.30 a.m., for a period of four weeks. The petitioner shall comply with the condition stipulated under Section 438 Cr.P.C. Scrupulously.

5. The petitioner shall appear before the concerned Magistrate within a period of 15 days from the date on which the order copy made ready, failing which, the petition for anticipatory bail stands dismissed.
