The above captioned appeals arise out of acquisition of land of the respondents in Village- Pehladpur Banger in pursuance to Notification of 27th October, 1999, under Section 4 of the Land Acquisition Act, 1894.

Learned counsel appearing for appellant/UOI states that the ground of challenge in these appeals is common one. In view thereof, the above captioned appeals were taken up for hearing together and are being disposed of by this common order.

Impugned judgment assesses the compensation of the acquired land on the basis of the minimum price for agricultural land, as determined by the Government. This method of assessment of compensation has been approved by a Coordinate Bench of this Court in LA.APP. No. 489/2008, '*Chiranjil Lal vs. UOI*', rendered on 2nd June, 2011, which has been relied upon by the Reference Court.

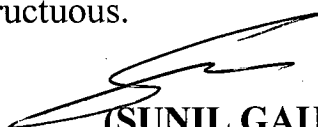
Learned counsel for the appellant/UOI assails the impugned judgments on the ground that there was lack of evidence on the part of the respondents-claimants and therefore, the compensation as assessed by the Land Acquisition Collector, ought to have been

upheld by the Reference Court.

It is also urged on behalf of the appellant/UOI that the Land Acquisition Collector in its Award had already factored the potentiality aspect while determining the market value of the subject lands and therefore, the impugned judgments ought to be set aside and Award given by the Land Acquisition Collector be restored.

Since the impugned judgment based upon the decision in *Chiranjil Lal (Supra)* correctly assesses the compensation, therefore, I find no merit in these appeals and the same are accordingly dismissed in *limini*, with no orders as to costs. Applications for stay are dismissed as infructuous.
